



MEDICARE DRUG COVERAGE UNDER PART A, PART B, AND PART D

This table identifies Medicare coverage of medically-necessary drugs in some common situations. It provides general guidance only and does not cover all possible situations. * Drugs are covered under Part D to the extent they are included on the formulary (list of covered drugs) for the person's plan. If a person's drug is not covered, he or she can ask the plan for a coverage determination, but may have to pay full price for that drug. ** Long-term care facilities include skilled nursing facilities (for stays not covered by Medicare), nursing homes which give skilled care, and institutions which give skilled care. Generally, "home" care setting includes Medicare-covered home health care, and "doctor's office" care includes hospital outpatient care.
